1. Information We Collect

2.1. Use of Data for Al Features

- This session-specific data is used solely for the purpose of providing the response and is not permanently incorporated into our core AI models.
- Al Model Training and Improvement: We may use anonymized and aggregated Customer Data to train, develop, and improve our Al models and the overall Services.[19] This helps us enhance the accuracy and capability of our platform.

3. How We Share Your Information

We do not sell or trade your Personally Identifiable Information. We may share your information with the following third parties:
